FIMBC MEMBERSHIP POLICY

1. New members must complete an application and have two current FIMBC members sign their application as sponsors. The application should be submitted to the Membership Chair and presented at a regular FIMBC Monthly Member meeting to be voted on.
2. The date of the application, along with the \$110 annual membership fee, will be noted and used if there are any first-come situations, such as boat slips, etc.
3. Annual memberships are due every year on March 1st. A grace period of 60 days after the due date will be given. A board member will contact the unpaid member TWO times, by either email, phone call, or both.
4. If the membership dues remain unpaid and there is no communication, the membership will be revoked. A new membership application must be completed and submitted if the person wishes to return. Consequently, the person forfeits all member benefits such as Campground Waiting list, Communication, Dock Slip Rentals, etc.
5. An annual membership may include a spouse.
6. Anyone doing business on FIMBC property during the camping season must have a good-standing paid membership unless authorized by the FIMBC board.
7. Members shall be responsible for their guests' behaviors.
8. A membership may be revoked if a member has been *convicted* of a serious criminal offense.
9. The Shelter House shall remain open to members and their guests at any hour, providing:
 - a. After midnight, noise should be kept to a minimum in consideration of other members and neighbors. Ways and Means Chairperson reserves the right to extend the time for Club-sponsored activities/events.
 - b. Members and guests using the shelter house shall be responsible for leaving the area in orderly condition.
10. Members may reserve the Shelter House for private parties. Reservations should be made with the Ways and Means Chairperson.

11. Children under the age of 12 must be accompanied or supervised by their parents or appointed adult guardians while they play or swim on Boat Club property. Children will follow Indiana state laws for operating motor vehicles.
12. Members and their guests will only use other members' campground lots for recreation, parking, etc. if the lot renter grants permission. Boat Club property is available for recreational activities to members and their guests.
13. Failure to comply with or abide by the above-listed rules and regulations may lead to loss of membership.



FIMBC CAMPGROUND WAITING LOT LIST POLICY

The French Island Marina Boat Club Vice President will maintain the Campground List.

Waiting List Rules:

1. Only members with good-standing paid memberships can be on the Campground Waiting list. Any membership lapse will cause that member to be removed from the list. If the person becomes a member again and wants to be added back to the list, that member will be added to the bottom of the list.
2. When a lot becomes available for rent, a board member reviews the lot list and contacts the member next on the list.
3. If a member on the waiting list has requested a specific lot and is unavailable, they will remain on the Campground Waiting list at their current position.
4. If a member has selected a specific lot ONLY, then the member will ONLY be contacted if/when that specific lot is available. If that specific lot becomes available, and they decline, the member has forfeited their current position and will be moved to the bottom of the list.
5. If a member is offered a First Available lot and declines, they have forfeited their current position and will be moved to the bottom of the list.
6. If a member has selected a specific lot and wants to change it to First Available, the member has forfeited their current position and will be moved to the bottom of the list.
7. A member may only select ONE lot as a preferred choice.
8. There is no subleasing, rent, or trade lots.

Rules for Transferring Lots

If a member cannot renew the lease due to relocation, illness, or death or simply decides to forfeit, they may only transfer the lot directly to the secondary leaser or descendant children.

The FIMBC Lot Lease will indicate a primary and secondary lessee for married couples or partnerships if applicable. Per the FIMBC Membership rules, one good-standing paid annual membership will include a married couple. Partners must each have a good-standing paid membership if they wish to rent a lot and be eligible for transfer.

If a married couple or partnership dissolves, the primary member will be considered first to continue the lease.

Descendant children must be 18 years old and French Island Marina Boat Club members in good-standing paid membership for two consecutive years. (This is stipulated in the Lease)

The FIMBC Board will approve all transfers.
