Members

As a perk of being a boat club member, you may rent the Shelter at no additional cost. A **Security/Cleaning Deposit** of \$50 is required. However, if the guidelines and cleanup are followed, the cash or check will be returned to you uncashed (please see the Rules). The check should be made out to French Island Marina Boat Club.

- Members renting must be in good standing with a current paid membership or have a Lifetime Membership.
- As a member, you can rent the shelter for your use or immediate family members, such as children, siblings, parents, or grandparents. We request that the member be present at the event.
- Extended family members or friends who are *not members* may rent the shelter at the cost listed below. We appreciate your understanding.

Non-Members

Rental fee:

- \$100 - One night/day
- \$50 - Any additional days prior to or following

A **Security/Cleaning Deposit** of \$50 is required. However, if the guidelines and cleanup are followed, the cash or check will be returned to you uncashed (please see the Rules). The check should be made out to French Island Marina Boat Club. Please pay your rental cost *separately*. **Cancellation Policy:** If you cancel your event, the rental fee will be refunded if you notify the Ways and Means Chairperson no later than 30 days before your event date.

Rules for FIMBC Shelter Rental:

How to Rent

Contact Makayla Ricketts, Ways and Means (812) 499-2259. She can approve your date and then notify Sandra Hadley, Communications, to add your event to the boat club calendar and website.

When requesting to rent the shelter, please provide:

- Dates for the rental
- Times (including setup and load-out)
- What is the type of event?
- How many people do you expect to attend?
- How would you like the shelter to be set up?
- Will there be music, and who will be providing it?

FIMBC will provide:

- Trash cans and liners
- Bathroom access with soap, toilet paper, and paper towels
- Cleaned tables and chairs (only what we have in inventory)
- A cleaned shelter floor

Cleanup:

- All trash must be removed from the cans and placed inside the dumpsters in the parking lot.
- All personal items must be removed by the end of the evening. FIMBC will not be responsible for any items left behind.
- If you have a significant spill, please clean it up.
- You DO NOT have to sweep or clean the tables.
- The Renter will close all doors at the end of the evening and make sure the lights are turned off.

Failing to follow these guidelines may result in forfeiting your security or cleaning deposit.

Rules:

- Events should conclude by midnight.

- The Renter is responsible for their guests and safe conduct for the entirety of the event.
- There is no loitering in the parking lot after midnight.
- Per Indiana State law, the legal drinking age for alcoholic beverages is 21 years or older.
- Any damages to the property or the property's tables and chairs will be the renter's responsibility to repair or replace.

FIMBC reserves the right to halt any event that does not adhere to the guidelines at any time.
